SECTION I: GENERAL TERMS & CONDITIONS

- 1. Offers should be based in 2 bid systems:
- i) Technical and commercial bid. (Sealed Envelope-A) The first envelope marked 'Technomust be sealed with sealing wax and should contain the technical & commercial details including the hard copy of the presentation.
- ii) Price Bid (Sealed Envelope- B) The second envelope marked 'Financial Proposal' must also be sealed with sealing wax and should contain the detailed price offer for the Services. Both the sealed envelopes should again be placed in a sealed cover, which will be received in the office of the undersigned.

ELIGIBLE CRITERIA:

- The Tenderers quoting as authorized representative of the manufacturer shall have 2 (Two) years of experience in the related work and should obtain documents from principals/manufacturer fulfilling the requirements in taking full responsibility of technical support, service and organizational support.
- 2. Please note that no counter proposal is acceptable to us and conditional / late quotations are liable to be rejected.
- 3. The bidder must submit the Earnest Money Deposit of (Rs 22,000) as EMD in the form of DD/BC drawn on any nationalized bank, pledge in favour of the Project Director, Meghalaya AIDS Control Society payable at Shillong along with the bid.
- 4. No advance will be given for taking up the said event.
- 5. No work will be allotted to non-tribal bidder, contractors, Suppliers, firms cooperative societies etc except under a valid trading license issued by the Autonomous District Council of the respective districts of Meghalaya.
- 6. The tenderer should submit attested copies of GST registration certificate & PAN Card.
- 7. Bidders/Tenderers have to agree to all the terms and conditions, stipulated in the tender document, in this connection including delivery penalty etc.
- 8. Bidders/tenderer shall undertake to sign the rate contract agreement within 7 (seven) days from the issue of the letter of Award, failing which EMD/security deposit may be forfeited.
- 9. The firm has to give an affidavit duly attested by the Notary Public (in original) on a non-judicial stamp paper of Rs. 10/- that there is no vigilance/CBI case pending against the firm and it has never been blacklisted by any public of private organization in the past.
- 10. Tender document is to be duly signed & sealed on all the pages as a token of having accepted all the terms and conditions (no thumb impression is to be affixed).
- 11. In case the Bidders/ tenderer furnish false information their tenders/ bids will be rejected and their security deposit/EMD will stand forfeited.
- 12. The bidders should have a sound financial background to implement the programme.
- 13. At any time prior to the date of submission of bid, Project Director, Meghalaya AIDS Control Society, Shillong, may, for any reason, whether at his /her own initiatives or in response to a clarification from a prospective bidder, modify the bidding documents by an amendment and it will be uploaded in the office website. All prospective bidders/tenderer are requested to visit the website regularly during this period. Project Director, Meghalaya AIDS Control Society, Shillong, may at his discretion, extends the date and time for submission of bids.
- 14. Meghalaya AIDS Control Society reserves all rights to make any changes in terms and conditions of the tender and also to reject any or all bids without assigning any reason thereof.
- 15. The tenders shall remain valid for acceptance for a period of 120 days (One Hundred and Twenty days) after the date of tender opening prescribed in the document.
- 16. The earnest money of the successful tenderer and the unsuccessful tenderers will be returned to them without any interest, whatsoever.
- 17. Tender sent by fax/telex/cable/electronically shall be ignored.
- 18. Bidders may quote the rate in Indian rupees only.

- 19. Within seven (7) days from date of the issue of notification of award by the purchaser, the supplier, shall furnish performance security to the purchaser for an amount equal to five percent (5%) of the total value of the contract, valid up to sixty days after the date of completion of all contractual obligations by the supplier, including the warranty obligations. In case the agency fails to deposit the performance security work order shall be cancelled.
- 20. Earnest Money Deposit (EMD) will be refunded after receiving the Performance Security from the successful bidder.
- 21. Settlement of disputes Project Director, Meghalaya AIDS Control Society or his authorized representative shall be the final authority in all disputes and decision will be binding
- 22. Supplier shall be entirely responsible for all taxes, duties, fees, levies etc. incurred until completion of the work.
- 23. Bills to be submitted in Originals.
- 24. Revenue stamp on all bills above Rs.2,000/-(Two Thousand)

SECTION II: SPECIAL TERMS & CONDITIONS

Background

The Office of The Project Director Meghalaya AIDS Control Society, Shillong has been implementing various activities & services in order to halt & reverse the epidemic of HIV/AIDS under the direction & guidance of the National AIDS Control Programme.

Scope of work of the Agency

Planning & implementation of district level music competitions culminating into a state level mega event in consultation with NACO, & MACS to engage, attract & promote the youth to participate in the event.

- Red Ribbon Superstar Meghalaya Icon Music Competition will be open to bands ONLY, and will be a multi-lingual event (participants can perform in any of the State's 3 languages) including English.
 - Auditions and short listings of contestants (date, time, location) in Shillong.
- Grand Finale to be held in Shillong City on the 1st December 2023. Venue to be decided in consultation with MACS.
- Band to present at least one original composition on the theme HIV/AIDS, noncompliance will lead to disqualification.
- Social Media Campaign (including Public interaction and activation)
- Permissions
- Logistics
- Publicity in electronic, print and convergent media covering all districts of the state of Meghalaya
- Prizes money of the winning bands (1st,2nd & 3rd) including the individual winners will be taken by MACS and shall not be included in the financial bid.
- Identification of panel of judges in consultation with MACS.
- Celebrity tie-ups (if any)
- Media partnerships
- Partnerships with music companies will be the responsibility of the firm.
- Other sponsorships (if available)

Keeping the following in mind MACS is inviting qualified agencies to submit EOI for the activities mentioned above:

Note: The agency shall not employ any sub-contractor for the contract awarded under this EOI.

Publicity in all the Districts

The agency should have a state wide reach including rural areas in Meghalaya. Identification and listing of strategic locations for publicity. EVALUATION OF QUOTATIONS

- The committee constituted for this proposal will examine the documents/credentials submitted by the firm. The firms will also require to give a detailed presentation on the proposed work plan, methodology and approach in response to the suggested terms of reference which will be followed by an interview (if shortlisted after the presentation & Techno-commercial evaluation) with the committee constituted for this proposal.
- The committee shall evaluate and compare the technical and financial bids and award the contract to any firm found to be substantially responsive and confirm to the terms and conditions and not necessarily the lowest rate.
- If the firm is considered unqualified after the presentation & Techno-commercial evaluation, the financial proposal will be returned unopened.
